

**NEW YORK STATE TEAMSTERS COUNCIL -
UNITED PARCEL SERVICE (“UPS”) RETIREE HEALTH FUND**

SUMMARY ANNUAL REPORT

This is a summary of the annual report for New York State Teamsters Council – United Parcel Service (“UPS”) Retiree Health Fund (the “Plan”), EIN 46-4111565 Plan No. 501, for the Plan year ended December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees has committed itself to pay certain hospital, surgical, medical, dental, vision, prescription drug, and other health related claims incurred under the terms of the Plan.

Insurance Information

The Plan has contracts with Excellus Health Plan, Inc. (d/b/a Excellus BlueCross BlueShield Central New York Region), Davis Vision, Inc., and Medco-Express Scripts to pay health, dental, vision and prescription drug claims incurred under the terms of the Plan. The total premiums paid for the Plan year ended December 31, 2021, were \$106,710.

Basic Financial Statement

The value of Plan assets, after subtracting liabilities of the Plan, was \$28,647,190 as of December 31, 2021, compared to \$33,198,873 as of December 31, 2020. During the year, the Plan experienced a decrease in its net assets of \$4,551,683. This decrease includes unrealized appreciation of \$804,194 in the value of the Plan’s assets; that is, the difference between the value of the Plan’s assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year.

During the Plan year, the Plan had income of \$2,528,486, which included participant contributions of \$1,180,800, earnings from investments of \$543,492, and unrealized appreciation in investments of \$804,194 as discussed above. Plan expenses were \$7,080,169. These expenses included \$529,270 in administrative expenses, and \$6,550,899 in benefits paid to participants and beneficiaries.

You have the right to receive a copy of the full annual report, or any part thereof, upon request. The items listed below are included in that report.

1. An accountant’s report;
2. Financial information and information on payments to service providers;
3. Assets held for investment;
4. Fiduciary information, including non-exempt transactions between the Plan and parties-in-interest (that is, persons who have certain relationships with the Plan);
5. Insurance information including sales commissions paid by insurance carriers; and
6. Information regarding any common or collective trusts in which the Plan participates.

You also have the right to receive from the Plan Administrator, on request and at no charge, a statement of the assets and liabilities of the Plan and accompanying notes, or a statement of income and expenses of the Plan and accompanying notes, or both. If you request a copy of the full annual report from the Plan Administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the office of the New York State Teamsters Council – United Parcel Service (“UPS”) Retiree Health Fund, 151 Northern Concourse, Syracuse, New York 13212, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
